## **Mecila: Maria Sibylla Merian Centre Conviviality-Inequality in Latin America**

### **What is Mecila?**

The collaborative project Mecila – Maria Sibylla Merian International Centre for Advanced Studies in the Humanities and Social Sciences Conviviality-Inequality in Latin America started in 2017. It has been investigating past and present forms of social, political, and cultural living together in Latin America and the Caribbean. Thereby, it wants to contribute to a better understanding of conviviality in diverse and unequal societies. Mecila is financed mainly by the Bundesministerium für Forschung, Technologie und Raumfahrt (BMFTR, Federal Ministry of Research, Technology and Space). After a three-year preliminary phase, the main phase began in April 2020 and will last until March 2026.

Mecila's headquarter is located in São Paulo (Brazil) with complementary hubs in La Plata (Argentina), Mexico City (Mexico), Cologne (Germany), and Berlin (Germany). In the consortium, German and Latin American universities and research institutions work closely together: the Freie Universität Berlin (main coordination), the Ibero-Amerikanisches Institut, Stiftung Preußischer Kulturbesitz, the Universität zu Köln, the Universidade de São Paulo, the Centro Brasileiro de Análise e Planejamento, the Instituto de Investigaciones en Humanidades y Ciencias Sociales (IdIHCS, Conicet / Universidad Nacional de La Plata), and El Colegio de México.

The Ibero-Amerikanisches Institut (IAI) coordinates within Mecila the Research Area Medialities of Conviviality and is in charge of developing Mecila's Information Infrastructure, which includes the articulation of the libraries of the institutions that constitute the Centre. Complementary, the Universität zu Köln coordinates the Research Area [Hi-]Stories of Conviviality and is responsible for the Research Data Management, while the Freie Universität Berlin coordinates the Research Area Politics of Conviviality and is in charge of the general coordination of the Centre.

The rationale of BMFTR's funding line Maria Sibylla Merian International Centre for Advanced Studies in the Humanities and Social Sciences is to establish strong platforms to interlink knowledge production in the so-called Global South more effectively with the so-called Global North. This is why Mecila cooperates closely with the other Maria Sibylla Merian Centres: CALAS in Guadalajara (Mexico), ICAS:MP in Delhi (India), MIASA in Accra (Ghana) and ME-CAM in Tunis (Tunisia).

## **An Innovative Research Network**

Mecila is conceived as a transnational, multidisciplinary, multi-institutional research network. It articulates pertinent research and outreach activities. Among these activities, rotating between the member institutions of the Mecila consortium, are Institutional Workshops, Thematic Workshops, Civil Society Workshops, and Public Lectures. Each Research Area of Mecila has developed complementary formats, both virtual and in presence. The Annual Meeting and Young Researchers Forum takes place in Mecila's headquarter in São Paulo. The Centre's primary research results are regularly published in Mecila's Working Papers Series, available online. Consolidated research results are published in books, edited volumes, and in articles and dossiers in indexed scientific journals. In cooperation with the Consejo Latinoamericano de Ciencias Sociales (CLACSO), the Mecila-CLACSO book series has been established.

## **The Institutions of the Mecila Consortium**

### **Freie Universität Berlin (FU Berlin)**

The Freie Universität Berlin (FU Berlin) owes its founding, in 1948, to international support, and international impulses have shaped the university's research activities and student life ever since. It is a full-spectrum university, comprising twelve departments and three Central Institutes which together offer more than 150 different academic programs in a broad range of disciplines. As an International Network University and part of the Berlin University Alliance, FU Berlin thrives on its many contacts with higher education institutions and organizations in Germany and abroad, which provide critical impetus for the university's research and teaching activities. Strong ties with Latin America and the Caribbean are anchored in the Lateinamerika-Institut (LAI, Institute for Latin American Studies). Founded in 1970, it is with 8 professors and about 50 research associates Germany's largest institute for research on Latin America and the Caribbean and also one of Europe's leading institutions for Latin American Studies. At the LAI, seven disciplines are represented in research and teaching in the social sciences, cultural studies and humanities. It develops in cooperation with Latin American and Caribbean institutions a broad range of research and teaching projects.

## **Universität zu Köln (UzK)**

Created in 1388, the Universität zu Köln (UzK) is the sixth university to be established in Central Europe. As a full-spectrum university, UzK is divided into six faculties (Management, Economics and Social Sciences; Law; Medicine, Arts and Humanities; Mathematics and Natural Sciences and Human Sciences). The research on Latin America has a long tradition at UzK and is promoted by the Centro Latinoamericano de Colonia (CLAC, Latin American Centre of Cologne), which also coordinates cross-faculty courses with focus on Latin America and the Caribbean. The Instituto de Historia Ibérica y Latinoamericana (IHILA, Department of Iberian and Latin American History) is the only major independent university institution in Germany devoted to the study of Iberian and Latin American history. Additionally, the Instituto Luso-Brasileiro (PBI, Luso-Brazilian Institute) is one of the largest and most traditional institutes of its kind in the German-speaking world. It deals with countries such as Brazil, Portugal, Angola and Mozambique from an interdisciplinary perspective. Since 2014, the Global South Studies Center (GSSC) articulates interdisciplinary research expertise in relation to Africa, Asia and Latin America, promoting cooperation among leading researchers in Germany and internationally.

## **Ibero-Amerikanisches Institut (IAI)**

The Ibero-Amerikanisches Institut (IAI, Ibero-American Institute), Stiftung Preußischer Kulturbesitz (SPK, Prussian Cultural Heritage Foundation) is a multi-disciplinary, nonuniversity institution of the humanities, cultural sciences, and social sciences. As an area studies institution it has a regional focus – Latin America, the Caribbean, Spain, and Portugal – while it also incorporates transregional interrelationships. This gives it a genuinely international orientation. An information centre, a research centre, and a cultural centre, all housed under the same roof and on an equal footing give the Institute its unique profile. The Library and Special Collections of the IAI are among the world's most outstanding on Latin America, the Caribbean and the Iberian Peninsula. The Institute develops its own research activities, is involved in collaborative projects with universities, hosts international visiting scholars and has a multilingual publishing program. It also carries out a broad spectrum of scientific and cultural events. The Institute's stable and sustainable structures are a decisive advantage here. The IAI has been a part of the Stiftung Preußischer Kulturbesitz since 1962. With its libraries, museums, archives, and research institutes, the SPK is one of the world's largest cultural and scientific institutions. It is jointly supported and financed by the German Federal Government and the Federal States, the Länder. The combination of different types of institutions, a broad spectrum of collections and diverse disciplines makes the SPK a great environment for the development of the IAI.

## **Universidade de São Paulo (USP)**

The Universidade de São Paulo (USP) is a public university founded in 1934 as part of an effort to modernize higher education in Brazil. USP is a state-operated university and does not charge tuition fees. The university offers a comprehensive range of programs across various fields of knowledge, including the humanities and social sciences. USP comprises 42 teaching and research units, six specialized institutes, four hospitals, four museums, 48 libraries, 15 archives, and a considerable number of well-equipped laboratories. With 333 courses, USP serves more than 60,000 undergraduate students. In addition, its graduate programs comprise 264 courses with approximately 37,000 students enrolled. USP accounts for 22% of Brazil's scientific production and frequently ranks as the top university in Latin America in terms of research output and quality. To carry out its activities, USP operates across eight campuses located in cities such as São Paulo, Bauru, Lorena, Piracicaba, Pirassununga, Ribeirão Preto, Santos, and São Carlos. Additionally, it has teaching units, museums, and research centres situated outside these campuses in various municipalities. Internationalization is one of USP's guidelines. The mobility of students and professors, as well as participation in networks and consortia, are the translation of this goal. Between 1,500 and 3,000 international students are received in its undergraduate and graduate programs each year.

## **Centro Brasileiro de Análise e Planejamento (Cebrap)**

The Centro Brasileiro de Análise e Planejamento (Cebrap) is a global research centre, founded in 1969 by intellectuals, most of whom were professors at Universidade de São Paulo (USP) who had been removed from the university by the regime established after the 1964 military coup. As in its origins, Cebrap's research focuses primarily on the analysis of the Brazilian reality. It adopts a comparative analysis approach, combining specialization and interdisciplinarity. The Centre draws on diverse theoretical and methodological perspectives from various fields, including Sociology, Political Science, Demography, Law, Philosophy, History, Anthropology, Economics and Geography. Today, Cebrap has established itself as a leading institution on the national scene and is known for its research projects, publications and seminars that follow a multidisciplinary approach and continue to have a significant impact on public debates. Over the years, Cebrap has conducted more than 500 research projects and collaborated with some 200 national and international partners. Cebrap disseminates its research through various channels, including the interdisciplinary academic journal "Novos Estudos", which features contemporary research. It also maintains a Virtual Library, housing video archives and articles produced by Cebrap, and organizes the traditional Cebrap Seminars, which foster discussions on Brazilian political and social reality.

## **Instituto de Investigaciones en Humanidades y Ciencias Sociales (IdIHCS), Conicet / Universidad Nacional de La Plata (UNLP)**

Founded in 1905, the Universidad Nacional de La Plata (UNLP) is the first and largest of the 21 free and public universities spread throughout the Province of Buenos Aires. Teaching, research, and extension are currently the fundamental pillars of the UNLP. The university comprises 17 faculties, with an enrollment of around 110,000 students. In recent years, an average of about 35,000 prospective students has applied for one of the 120 degree programs offered by the UNLP. Each year, approximately 7,000 students graduate from its programs. Since its creation in 1920, research has been a distinctive activity of the Facultad de Humanidades y Ciencias de la Educación of UNLP, achieving progressively greater institutionalization through the formation of specific units: institutes, centres, and areas. The IdIHCS was established in August 2009 with the aim of integrating and strengthening these units and their researchers. It operates as a dual-dependency entity of both UNLP and the Consejo Nacional de Investigaciones Científicas y Técnicas (Conicet). Since June 2010, it is also a member of the Consejo Latinoamericano de Ciencias Sociales. The objectives of IdIHCS are to promote, carry out and coordinate theoretical, empirical, and methodological studies in the field of social sciences and humanities. Among its key functions are: the elaboration and execution of research programs and projects; collaboration in the training of young scientific researchers; the provision of advice and transfer of knowledge and/or research tasks for institutions that require it; and the organization of scientific meetings (congresses, symposiums, conferences and research forums, meetings, etc.), as well as courses, seminars and research workshops. With more than 270 researchers, 157 doctoral and postdoctoral fellows, 12 research support professionals and 3 administrative agents, IdIHCS is the largest Conicet humanities and social sciences research centre in Argentina.

## **El Colegio de México (Colmex)**

El Colegio de México (Colmex) is an outstanding social science and humanities research and teaching institute. Created in 1940, the origins of Colmex are linked to La Casa de España, which received many distinguished exiled scholars during the Spanish Civil War (1936-1939). The institution operates as a small public university and research centre with a highly specialized faculty, an excellent academic library and a program of high-level seminars and conferences on cutting edge issues of the contemporary world as well as in many academic disciplines. Its eight academic centres offer degrees in the following fields: Master's and Doctoral degrees in History, Sociology, Economics, Political Science, Linguistics, Literature, Asian and African Studies, Urban Studies, Demography and Environmental Studies, a Master's Program in Gender Studies, and undergraduate degrees in International Relations, Public Administration and Economics. Admission is based on open and very rigorous competition for candidates from Mexico and abroad. Virtually all accepted students obtain scholarships, which require full time dedication to their academic program. El Colegio de México has numerous, ongoing academic exchanges with many high-level educational institutions around the world.

## **The Research Areas of Mecila**

### **Research Area: Medialities of Conviviality**

The Research Area Medialities of Conviviality analyses, through the lens of inequality and difference, processes of co-production, circulation, and appropriation of knowledge, imaginaries, and representations. These processes include movements of persons, ideas, values, and objects. Practices such as writing, drawing, photographing, collecting, and exhibiting offer clues to the study of how notions of conviviality – for instance, utopias or mythical pasts – become manifest in objects that are produced, negotiated, and circulated in unequal convivial configurations. Digital transformation is shaping the circulation of knowledge in new and unprecedented ways, reducing old inequalities but also producing new ones. The knowledge dimension and the ways and means of mediation are key to understanding the nexus between conviviality, difference, and inequality.

### **Research Area: [Hi-]Stories of Conviviality**

The Research Area focuses on the question of how convivial configurations evolve and interact to bring about changes in convivial regimes, favouring a diachronic approach without limiting itself to it. One prominent field of inquiry is labour relations: forced labour arrangements and resistance to it in colonial settings; informal and formal labour and their relationship in historical and contemporary Latin America. Another field consists of the legal settings and everyday negotiations of legitimacy and illegitimacy in family formation and their connection with social hierarchies and group formation. Finally, Latin America's heterogeneous urban populations and the historically grown power hierarchies is on the focus. In all our research projects, the tensions between norms (socio-political, legal, moral, or economic) and convivial realities and practices play an important role.

### **Research Area: Politics of Conviviality**

The main concern of the Research Area lies in how markers of difference are negotiated in contexts of power asymmetries and subsequently impact patterns of inequality within convivial configurations. It inquires how various agents either enhance or challenge existing inequalities through their everyday and institutional practices. The scope of this Research Area is not limited to the realm of institutionalised politics, macro-structures, and top-down power relations: politics also encompasses everyday life interactions, unstably codified practices, unspoken conflicts, and informal agreements, which are also marked by inequality and conviviality in particular ways. In this sense, both the public and private spheres of social life are eminently political.

## The Mecila Information Infrastructure

The Mecila Information Infrastructure stands as a cornerstone of academic and cultural exchange between Germany and Latin America. It has been developed in close collaboration with leading institutions across the region, including the Daniel Cosío Villegas Library of El Colegio de México (COLMEX, Mexico), the Library of the Instituto de Estudos Brasileiros at the University of São Paulo (USP, Brazil), and the Biblioteca Prof. Guillermo Obiols of the Facultad de Humanidades y Ciencias de la Educación, Instituto de Investigaciones en Humanidades y Ciencias Sociales (IdIHCS–CONICET/Universidad Nacional de La Plata, Argentina). The Mecila Information Infrastructure supports the interdisciplinary, international and multi-institutional research network Mecila, funded for the funding period 2020 to 2026 by the Bundesministerium für Forschung, Technologie und Raumfahrt (BMFTR, Federal Ministry of Research, Technology and Space) and coordinated by the Ibero-Amerikanisches Institut (IAI) in Berlin (Germany).

Since its inception, Mecila has brought together scholars from diverse fields to examine pressing social transformations in Latin America, from urbanization and migration to cultural identity and political change. It has been investigating past and present forms of social, political, and cultural living together in Latin America and the Caribbean. It wants to contribute to a better understanding of conviviality in diverse and unequal societies. For researchers working at the Mecila Hub in São Paulo, secondary nodes in Argentina, Mexico and Germany, or from distant academic centers, access to specialized literature can be a persistent challenge. The Mecila Information Infrastructure addresses this by creating an articulated digital information ecosystem that bridges geographical, institutional and disciplinary divides and provides researchers with specialist literature. Far more than a mere digital library, it functions as a interconnected knowledge infrastructure, integrating analog and digital resources, enabling seamless access to rare and often not accessible materials, and fostering a shared research environment across continents.

At the core of the Mecila Information Infrastructure is the Mecila eLibrary, a secure, virtual reading room designed specifically for copyrighted print materials that are not available in digital form. Access is restricted to registered Mecila members (Principal Investigators, Associated Investigators, Postdocs, Junior and Senior Fellows, Doctoral Researchers) and provided in compliance with German copyright law, ensuring legally compliant and equitable access to the materials. As of early 2025, the eLibrary hosts over 330 digitized titles, all selected from the Ibero-Amerikanisches Institut's extensive print holdings and curated according to their relevance to Mecila's research themes. The collection includes works in English, Portuguese, and Spanish, covering a broad spectrum of social, cultural, and political topics central to Mecila.

Access to the Mecila Information Infrastructure is straightforward and free for all project members, including Principal Investigators, Associated Investigators, Postdocs, Junior and Senior Fellows, Doctoral Researchers. After personal registration, users are granted access to the services of the infrastructure, including the Mecila eLibrary, as well as to all digital resources of the IAI. While the eLibrary offers targeted access to digitized monographs,

the Mecila Information Infrastructure provides users with access to the catalogues and services of all participating partner libraries. This includes the Online Public Access Catalogue (OPAC) and digital services of the Ibero-Amerikanisches Institut, as well as those of the Daniel Cosío Villegas Library at El Colegio de México (Mexico), the Library of the Institute of Brazilian Studies at the University of São Paulo (Brazil), and the Professor Guillermo Obiols Library of the Facultad de Humanidades y Ciencias de la Educación / IdIHCS, Conicet / Universidad Nacional de La Plata (Argentina). These resources, combined with the ability to request digitization of specific materials, ensure that researchers can access the scholarly foundations they need, regardless of location.

To this end, the responsible colleagues for the Mecila Information Infrastructure at the four partner institutions regularly coordinated their joint information services, exchanged experiences and jointly developed ideas for new, needs-based services for the Mecila Information Infrastructure. This exchange contributed significantly to the internationalization and networking of the libraries and to the further development of their respective services.

In a first Institutional Workshop of the Mecila Information Infrastructure, which was held in 2022 in direct temporal and thematic connection with the Mecila Thematic Workshop "Latin American Knowledges in Circulation: Mediating Differences in Convivial Contexts" of the Research Area Medialities of Conviviality, also held at the IAI in Berlin, cooperation between the participating libraries was strengthened and the direct connection to the Research Area was highlighted. For Mecila, the Information Infrastructure is not just a service provider. With its combination of analog and digital collections, associated practices, and various collection-related expertise, it is also a partner in the examination of possible inequalities and hierarchies in knowledge archives and collection institutions and the strategies for overcoming them. These central themes were discussed in the Mecila Annual Meetings in 2023 and 2024, at another Thematic Workshop in 2023, and at the Mecila Civil Society Workshop in 2025, all organized by the Research Area Medialities of Conviviality.

Looking ahead, the Mecila Information Infrastructure will be further strengthened through the Mecila Institutional Workshop in Berlin from February 18<sup>th</sup> to 20<sup>th</sup> 2026, bringing together researchers, librarians, and technical coordinators to evaluate current practices, discuss future developments, and enhance the platform's usability. This event underscores the Mecila Information Infrastructure's role not only as a repository of knowledge but as a living, evolving space for collaboration that reflects the dynamic, transnational nature of contemporary research in Mecila and the Ibero-American world. By integrating institutional expertise, digital innovation, and a commitment to equitable access, the Mecila Information Infrastructure exemplifies how modern research infrastructures can transcend borders, enabling scholars to work together, share insights, and advance understanding across continents.



## Biographical Notes

### Archuby, Gustavo

Gustavo Gabriel Archuby is a Computer Analyst from the School of Computer Science, National University of La Plata (UNLP). He currently serves as Director of Information Technology at the School of Humanities and Education Sciences (FaHCE – UNLP), and as Lecturer and Faculty Member in the Library and Information Science Program at FaHCE. He is also a member of the Academic Council of FaHCE – UNLP. His professional experience includes consulting for ARSAT, with a focus on training and developing artificial intelligence platforms on local infrastructures and free software. He was in charge of the IT area of the project “Strengthening the Capacities of Provincial Archives” (2022–2024), coordinated by the Federal Council of Investments, the Government of the Province of Buenos Aires, and UNLP. Between 2004 and 2014, he served as consultant for the installation and support of CLACSO’s Virtual Library. Is also engaged in research projects such as “The Representation of Territory in Scientific Discourse” (2023–2026, UNLP–CONICET) and the development of an AI-based technological tool for academic literacy (2023–2026, UNLP–CONICET). His recent publication includes “Institutional Repositories and Artificial Intelligence Platforms: Open Access for All?” (2025), available at Memoria Académica – UNLP. In the field of teaching, he has organized and lectured in seminars such as “Introduction to Generative Artificial Intelligence in Library and Information Science” (2025, FaHCE – UNLP), “Fundamentals of Language Models and Artificial Intelligence Platforms” (2025, Postgraduate Diploma on AI and Education, FaHCE – UNLP), and “Open Science: Conceptualizations and Tools” (2023, UNLP). He is currently responsible for the Postgraduate Diploma in Artificial Intelligence and Education (2025, FaHCE – UNLP).

### Berger, Frederik

Frederik Berger is head of the Department Services in the Science Program Collection Future of the Museum für Naturkunde Berlin. He studied Archaeology and Art History at the Johannes-Gutenberg University Mainz and holds a PhD with his thesis on the history of 19th century archaeological collections. He received further qualification in Information and Library Science at TH Köln. At the Museum für Naturkunde Berlin he developed and implemented the collection digitisation program since 2018. His research and work focuses on the digital transformation of collections and the development of collection based services. He is principal investigator of the EFRE-funded project ELIO (Entwicklungslabor für Innovation in der Objektdigitalisierung – Lab for innovation in object digitisation), which aims at establishing digitisation services as a business model in GLAM institutions.

### Birle, Peter

Mecila Principal Investigator Peter Birle is Director of the Research Department of the Ibero-Amerikanisches Institut (IAI) and teaches at Freie Universität Berlin. He was Mecila German Director in Presence from April to September 2023 in São Paulo. He holds a PhD in Political Science from Johannes-Gutenberg-Universität Mainz. He is member of the the Executive Board of the Arbeitsgemeinschaft Deutsche Lateinamerikaforschung (ADLAF). He was an Assistant Professor at Universität Rostock and Visiting Professor and Researcher at Pontificia Universidad Javeriana in Bogotá. Peter Birle’s research interests include Latin American foreign policies in comparative perspective, regional cooperation and integration in Latin America, comparative analysis of Latin American political systems, and knowledge production in and about Latin America.

### Costa, Michelli

Michelli Costa holds a PhD and a Master’s degree in Information Science, as well as a Bachelor’s degree in Library Science from the University of Brasília (UnB). She has experience in the field of Information Science, with an emphasis on open science, digital libraries, and initiatives aimed at democratizing access to information. Since 2017, she has served as a professor at the School of Information Science at UnB. She coordinates the extension projects “Comunica Mulher: Information Service to Combat Violence Against Women” and “Biblioteca Popular Catando Palavras.” She also coordinates the research project “Digital Collection Memorial Paulo Freire: The Struggle of Social and Popular Movements for the Education of Young People, Adults, and Elderly Workers (EJA),” which, aligned with the principles of digital humanities, develops the Portal and digital library of Brazil’s EJA Forums. Between 2018 and 2020, she contributed to the development and implementation of the 4th National Action Plan of the Open Government Partnership, focusing on the creation of scientific data governance mechanisms to advance open science in Brazil. She serves as a member of the Advisory Committee of Building Strong Library and Information Science Education (BSLISE), a working group of the International Federation of Library Associations and Institutions (IFLA).

### Göbel, Barbara

Barbara Göbel is Director of the Ibero-Amerikanisches Institut (IAI), Honorary Professor at the Institute of Social and Cultural Anthropology at Freie Universität Berlin and President of the Arbeitsgemeinschaft Deutsche Lateinamerikaforschung. Barbara Göbel is Mecila Principal Investigator and leader of the Mecila subproject at IAI. She studied social anthropology, prehistory, and economic and social history at Ludwig-Maximilian-Universität München and holds a PhD from Universität Göttingen. She has been involved in several international, interdisciplinary projects and is member of multiple boards and review panels of national and international organizations and funding agencies. She worked at the Universities of Göttingen, Tübingen, Stuttgart-Hohenheim, Köln and Bonn in Germany and at the Laboratoire d’Anthropologie Sociale, Collège de France and has served as Visiting Professor at several universities in Argentina, Bolivia, Chile, Peru, and the United States. In 2022, she received the Premio Leloir from Argentina as a recognition of her engagement for the internationalization of sciences. Her main research interests are anthropology of nature; socio-environmental inequalities; geopolitics of knowledge; infrastructures of knowledge and digital transformation.

### **Hermann, Sibylle**

Sibylle Hermann is Chair of the VDB Commission for Research-Oriented Services. She holds a PhD with a strong focus on Open Science; her work addresses how transparency, reusability and appropriate recognition of research outputs can be achieved within academic evaluation systems. She is Head of the Union Catalogue and Consortium Systems Department (SWB-Verbandssystem) and Deputy Director at the Library Service Centre Baden-Württemberg (BSZ), where she shapes strategic development and research-oriented information infrastructures.

### **Mering, Sabine von**

Sabine von Mering is head of the Research Group Data for Nature at the Museum für Naturkunde Berlin. She studied Biology at the Friedrich Schiller University Jena and the University of Hamburg, taking additional courses in Latin American Studies, and holds a PhD in Systematic Botany. After transitioning into research data management and biodiversity informatics, she has spent many years working as a researcher and coordinator on national and international biodiversity data initiatives. Since 2020, she has worked as a data scientist in the Science Programme Collection Future, focusing on opening up and linking collection data, and knowledge contextualisation. Her academic interests include botanical research, the history of natural history collections, and biodiversity data standards. Currently, she works on research expeditions, women in natural history, and networks of collection agents. An advocate for Open Science and Wikidata as a research tool, she also has an affinity for interdisciplinary approaches.

### **Müller, Christoph**

Christoph Müller works at the Ibero-Amerikanisches Institut (IAI) in Berlin as vice-director of the library, director of the Digital Library department and director of the Central America, Colombia, Venezuela and the Spanish-speaking Caribbean Collections. He studied Romance Philology and Art History at the Technical University of Aachen (RWTH Aachen). He received a PhD from the RWTH Aachen with a thesis on the Arcadia Lusitana, an eighteenth-century Portuguese literary academy. His current fields of research are digital transformation in libraries and Latin American literature from the 19<sup>th</sup> to the 21<sup>st</sup> centuries (especially science fiction literature, comics/fanzines and serials). He is principal investigator of the Mecila: Maria Sibylla Merian Centre Conviviality-Inequality in Latin America funded by the Bundesministerium für Forschung, Technologie und Raumfahrt (BMFTR, German Federal Ministry of Science, Technology and Space) and, at the moment, he is German Director in Presence of Mecila in São Paulo.
